Chief’s Report: Fire Chief Comer opens the floor to questions and discussion ensues.

A motion to approve the ‘Chief’s Report’ was made by Commissioner Allen, seconded by Commissioner Barbosa ...Motion carried. Call and question, all in favor aye.

Attorney’s Report: Attorney Pringle advises following the January 21 board meeting, a letter was prepared for the Chairman’s signature and sent to Representative Botana, with copies provided to the board and local delegation members. The letter outlined the district’s position, noted 36 signatures in opposition, confirmed no public support for House Bill 4013, and requested withdrawal of the bill.

House Bill 4013 continues to advance through the Florida House, having been approved by the State Affairs Committee and placed on the House calendar for second reading. The Senate has not yet taken action. Outreach efforts in Tallahassee remain ongoing to communicate the bill’s potential adverse impact on the district.

The Board discussed initiating contact with legislative aides to explore opportunities for engagement and potential meetings. It was agreed that staff will reach out to determine what level of interaction may be available, including the possibility of a face-to-face meeting, as Commissioners Barbosa and Allen expressed interest. Any identified opportunities will be reported back to the Board for direction.

It was noted that discussions with legislative aides may be brief and informal in nature; however, the Board directed staff to proceed with outreach and make the attempt promptly.
