- With Lieutenant promotional processing concluded, we anticipate announcing three Lt. promotions very soon.

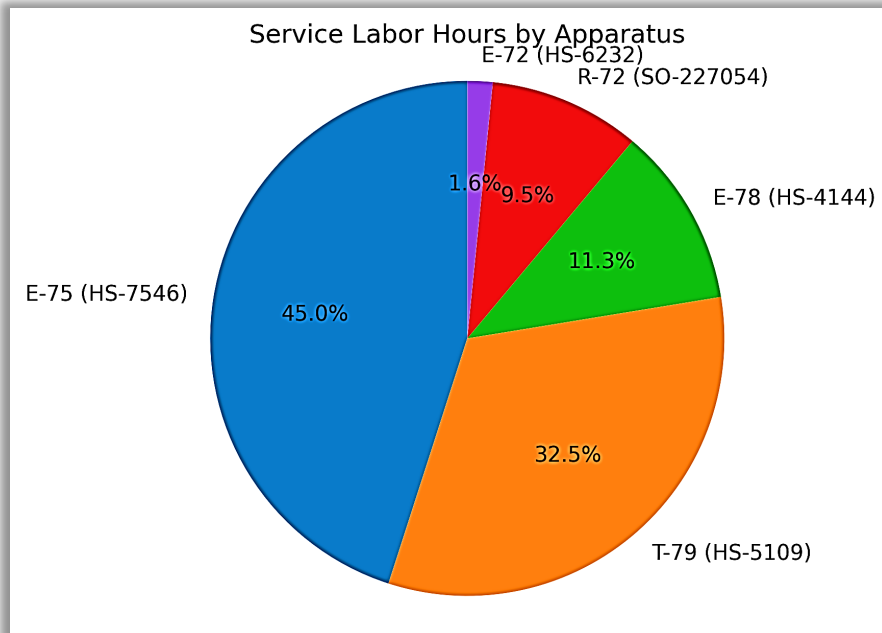
### Operations:

### Logistics:

#### Fleet Maintenance

- Fleet maintenance is on schedule with the fleet receiving over 55 hours of service in February.
  - E77 was placed into service at Station 73.
  - Iona 4 and Iona 9 were moved to FIT Auto for their upfit and radio installation.
  - M70 received its new Sierra Wireless unit, and it was installed by Motorola.



#### Technology Upgrades

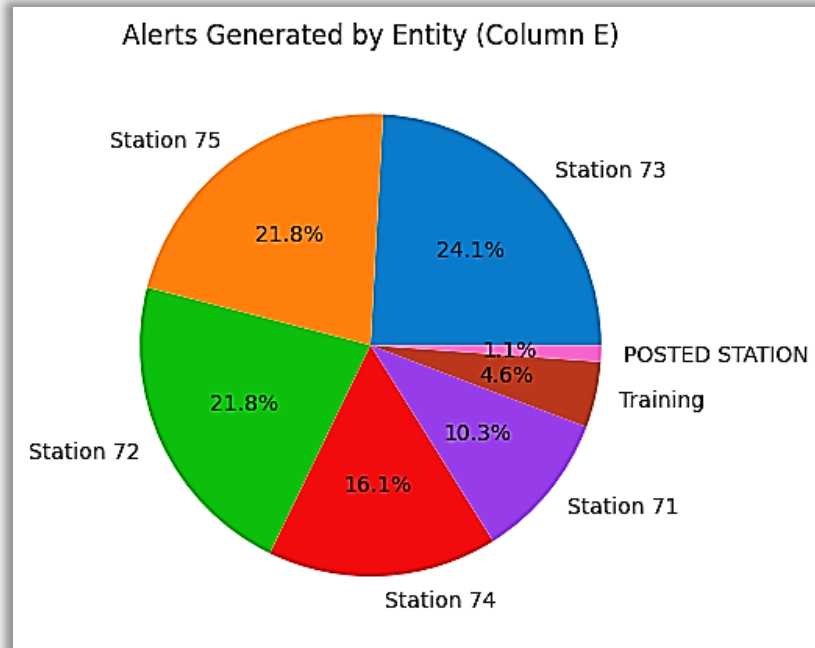
- Eleven new APX NEXT radios were placed into service,
  - These radios provide a cleaner sound and are able to transmit over the LTE wireless system when the radio towers fail.

**Facility Updates**

- U.S. Digital Designs IP dispatch system was fully installed.
  - The district is now fully up to date with Lee County Dispatch current technology.
- The District change over to the new phone system is complete

**PSTRAX**

- Logistics received 89 alerts in February. 58 alerts were completed with the rest waiting on parts, vendors, or service from third party vendors.

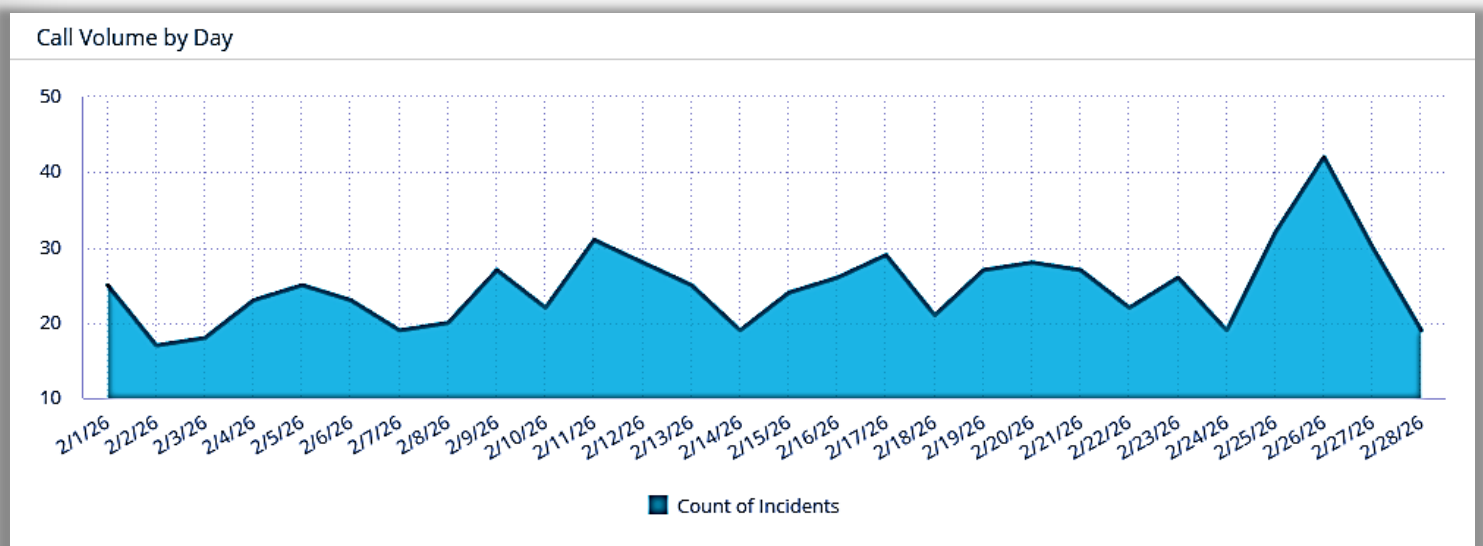
- On February 3rd, on duty personnel presented the District's Friendly Firefighter Program for Camp HSR homeschool students at Fort Myers Congregational Church, teaching fire safety through interactive demonstrations and activities.
- On February 4th and 12th, IMFD hosted CPR classes for Indian Creek and Holiday Condo residents, equipping 30 participants with critical lifesaving skills and hands-on training to strengthen community emergency preparedness.
- On February 21st, the District hosted its 6th Annual Camp Brave Heart, a girls' youth empowerment camp. The event welcomed 36 campers, along with local counselors, counselors from across the state, and several IMFD staff members for a day of mentorship and encouragement. This year's theme, "Be Brave. Be Fierce. Be You.", encouraged young girls to build confidence, resilience, and leadership skills.

## Fire Training/Special Operations:

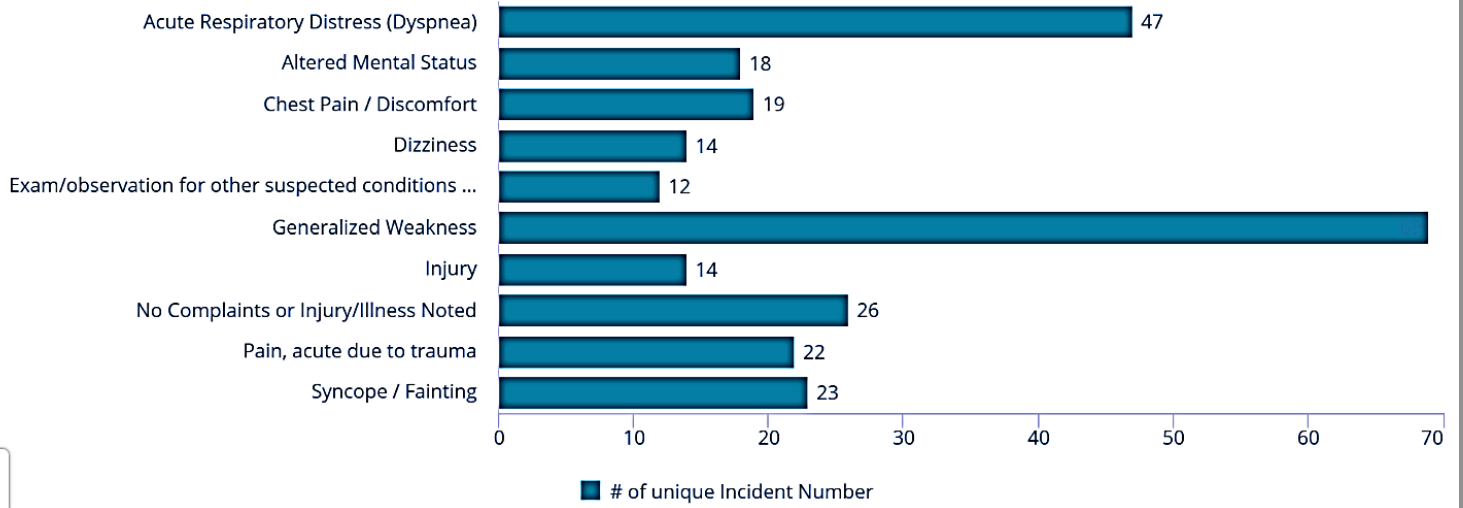
- All operations members participated in the Annual Skills Evaluation. During this process members complete a turn out drill, deployment of a 24' ground ladder with proper tool package, and deployment of a pre-connect attack line. Times are recorded and shared with our members so they can be aware of their individual performance year over year.
- Captain Barber led members through a quarterly hazmat drill at Station 74. Members worked on identification and initial engine company actions at a hazmat event.
- Dive training this month was conducted at Mastique and focused on the full deployment of a rapid diver operation.

## EMS, Health and Safety:

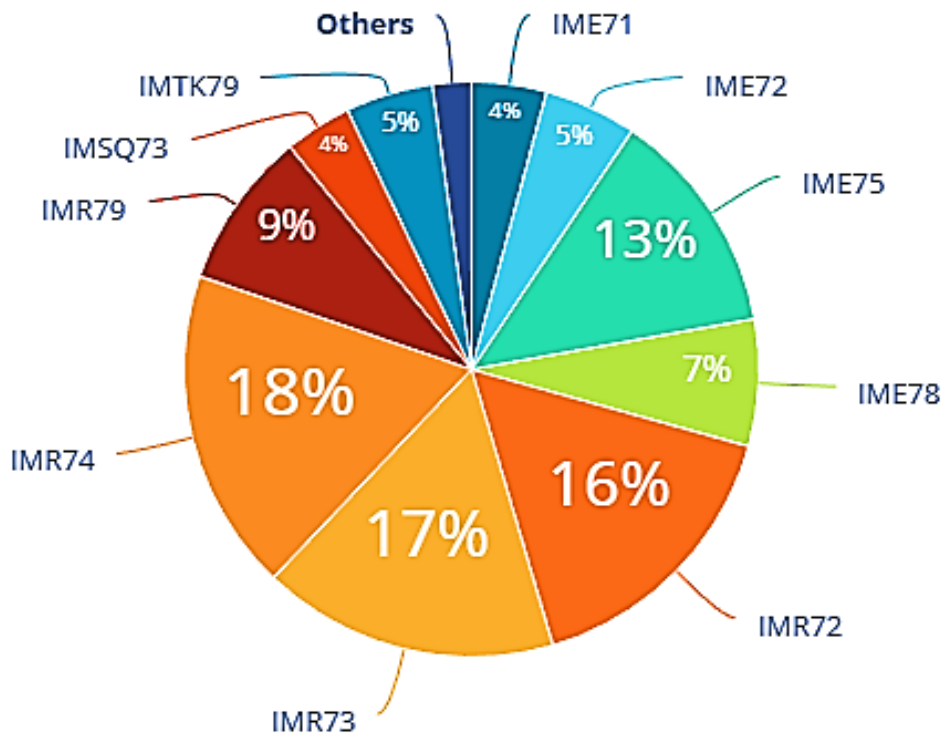
- New SCBAs were put into service. 50 2025 Scott XD SCBAs along with 100 cylinders, 8 RIT Packs, and a new Air Cart were inventoried and placed into service, replacing the previous 2014 Scott X3 SCBAs. These new SCBAs maintain compliance with NFPA standards for serviceability and safety and will be in service over the next 10-15 years.
- The SCBA storage room at Station 75 was updated with a workstation and new shelving to improve the storage of the new SCBAs and provide a workspace for the eventual Tech Level 1 personnel to complete basic repairs and maintenance in-house.
- All EMTs and Paramedics completed bi-annual renewals for BLS, ACLS, and HandTevy certifications. BLS and ACLS certifications are required to maintain State EMT or Paramedic licensure and must be renewed every 2 years. We also onboarded four new BLS and ACLS Instructors.



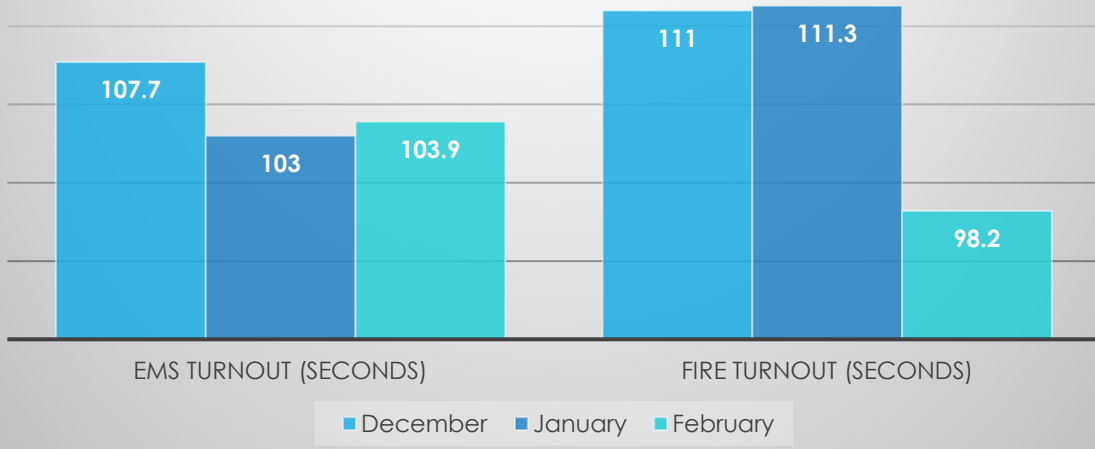
### Top 10 Primary Impressions



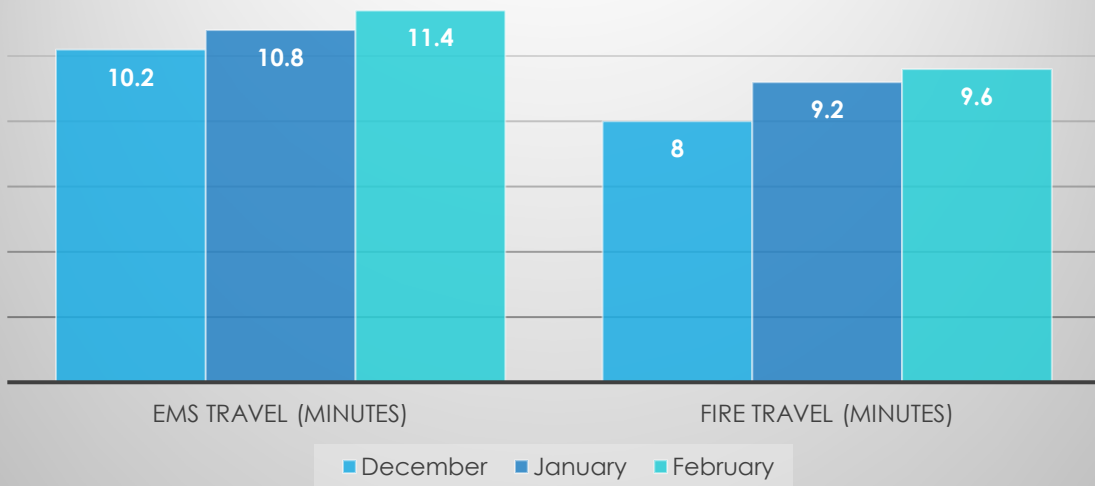
### EMS Call Volume % by Unit
