a. Discussion of Agenda Item

At a Special Board Meeting called and duly noticed for the purpose of discussing and potentially taking action regarding the proposed involuntary merger of the Iona

McGregor Fire Protection and Rescue District and the Fort Myers Beach Fire Control District pursuant to House Bill 4013, Attorney Pringle provided the Board with an overview of the status of the legislation and discussed statutory limitations related to the District's ability to address the referendum question. Attorney Pringle advised that, as of April 28, 2026, the Governor had neither signed nor vetoed House Bill 4013. Attorney Pringle further reviewed correspondence previously authorized by the Board and signed by Chairman Andersen requesting Governor DeSantis veto the legislation, and noted that Fort Myers Beach Fire Control District had likewise submitted correspondence requesting a veto. Attorney Pringle discussed the applicability of Section 106.113, Florida Statutes, including revisions effective July 1, 2022, and explained that the statute significantly limits and restricts the District's permissible activities related to advocating for or against referendum matters. Following discussion, the Board requested that a proposed resolution related to the matter be prepared for consideration at the regular Board meeting scheduled for May 20, 2026. The Board also requested a future agenda item to discuss coordination of an open community forum, including options for electronic attendance participation and the potential posting of informational materials on the District website.

Kerri Peroni, of Whisky Creek, expressed curiosity regarding Fort Myers Beaches perspective, Fort Myers Beach was not in favor of the merger.


