Balance Sheet

Cash and Investments

Cash and cash equivalents of \$1,570,752 and investment balances of \$3,414,131 are reported on the Balance Sheet and Summary Financial Statement - General Fund. The rate of return on surplus funds held in Florida PRIME (Florida Local Government Investment Pool) for the month of August was 86 basis points, up from 78 basis points in September.

Other Assets

Prepaid insurance represents premiums paid on the group health insurance policy.

Liabilities and Accrued Expenditures

The District reports a permanent donation in the amount of \$722.00 to be deposited into a District foundation. The Health Insurance Rebate represents the amount refunded from Florida Blue for our 2015 policy year based on the Medical Loss Ratio calculation. A pro-rata portion will be refunded to employees and retirees based on amounts contributed. FRS accrued expenses represents the employees' portion of the October 2016 retirement contribution due after the end of the month.

Fund Balance

The first account listed in this category, Retained Earnings-Current Year in the amount of (\$658,566), represents the amount of current year revenues over/(under) expenditures. The next account, Prior Year Revenues Over/(Under) Expenditures (\$574,028) represents revenues over/(under) expenditures from the previous two fiscal years. Fund Balance - Nonspendable totaling \$128,059 consists of prepaid assets at the end of the prior year that are not available to satisfy current obligations. Fund Balance - Assigned of \$200,000 was established by the board in anticipation of future health insurance cost increases. Fund Balance - Unassigned of \$5,983,076 represents the balance of prior years' reserves carried forward.

Summary Financial Statement

Revenues

The District did not receive any ad valorem tax collections during the month of October. Tax bills are payable as of November 1st and include a 4% discount if paid in November.

Total revenues represent 0.14% of budgeted revenues.

Expenditures

Personnel services are reported at \$535,881 or 3.74% of budget. Operating expenditures (which include professional & contractual, travel, communications & freight, utilities, equipment rental & insurance, other operational and administrative, supplies, tools & small equipment and education and training) total \$148,262 or 6.44% of budget. There were no expenditures for Capital Outlay or Debt Service as of October 31, 2016

Total expenditures represent 3.84% of budgeted expenditures.
