1) Meeting Minutes – April 15, 2020

Motion (5706) to adopt minutes of April 15, 2020 made by Commissioner Andersen, second Commissioner Langford... carried.

2) Financial Report – April 2020

Report provided previous and CFO Winzenread is available for questions. Following no questions, **motion** (5707) to approve April 2020 financial report made by Commissioner Langford with second offered by Commissioner Andersen... carried.

3) Audit Presentation

Jeff Tuscan with Tuscan & Company was introduced and gave brief presentation of the 2019 audit beginning with Opinion Letter. We have received highest level an auditor can issue. No material weaknesses, no non-compliance was noted. Cash and investment test identified that District is in compliance with regulations. Graph detail was presented and reviewed. The current depreciation threshold is \$1,000 and next year it is changing to \$5,000. Pension liability is our portion of FRS liability calculated by actuary study by State reducing the projected rate of return at 6.9%, and our workforce is younger which increases the liability. Net OPEB liability is projected future cost of providing insurance for retirees until they reach Medicare age. Following presentation, **motion** (5708) was made by Commissioner Langford to approve the audit as presented. Motion was seconded by Commissioner Louwers. Chair called for roll vote whereby Commissioners Langford, Louwers, Andersen, Barbosa, and Walker all in favor; passed unanimously.

4) Commission Election

Attorney Pringle described the election process to Board, including the necessity for the Board to formally adopt a resolution calling for the election for the termed seats. He then read the resolution in the record as, "Resolution 2020-01, A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE IONA MCGREGOR FIRE PROTECTION AND RESCUE SERVICE DISTRICT, LEE COUNTY, FLORIDA, ORDERING AND CALLING AN ELECTION OF MEMBERS FOR THE BOARD OF COMMISSIONERS TO BE HELD IN THE GENERAL ELECTION ON NOVEMBER

5) Surplus Item

It is requested that a fog smoke machine which is no longer used and has a value of less than \$250.00 be deemed surplus, and the chief authorized to dispose of the item in accordance with FS 274.06. **Motion** (5710) to deem item surplus and authorize Chief to properly dispose of was made by Commissioner Langford, seconded by Commissioner Andersen. Following call for roll vote, results were Commissioners Langford, Andersen, Louwers, Barbosa, and Walker all in favor. Motion carries.

6) Codification Resolution (For Discussion Only)

Attorney Pringle provided Board with a draft resolution and corresponding documents to be reviewed and brought back for discussion and possible action at the June 2020 meeting. He briefly described the items included in the resolution as well as the some of the exhibits attached. It was recommended that a workshop be conducted to fully review and explain the documents contained within. Commissioner Walker mentioned that he is not sure that all of this is necessary and relevant to us since goes back to 1980. Louwers stated that an hour-long workshop wouldn't be bad. Langford agrees to have workshop as does Andersen. No action taken. Workshop could be an hour before regular June meeting, and needs to be advertised. **Motion** (5711) to establish Workshop for June 10, 2020 beginning at 5p.m. was offered by Commissioner Walker, second Commissioner Andersen... carried.

Notable items on the Balance Sheet:

Cash and Investments

The rates of return on surplus funds for the month of May were are as follows: 0.77% - SBA (Florida PRIME Local Government Investment Pool) 0.25% - BankUnited - Money Market

Liabilities

Liabilities totaling \$15,796 consist of trade accounts payable.

Notable items on the Statements of Revenues and Expenditures:

Revenues

- Received approximately \$236,000 in ad valorem tax revenues during the month of May. Through May 31st, we have received 98/% of the annual budgeted total.
- Received \$21,976 in grant funds from FEMA (passed through the State of Florida) for the reimbursement of expenditures for the deployment of personnel during Hurricane Dorian in September 2019.
- Received Lee Co EMS rent for Jul-Sept in the amount of \$8,363.
- Inspection fee receipts during May totaled \$5,442.
- Interest on invested surplus funds totaled \$9,558 for the month of May. The interest rate for the FL PRIME investment pool dropped an additional 18 basis points from the prior month, a decrease of about 19%. The money market interest rate remained unchanged

Expenditures

- Paid \$35,305 to Lee Co. for annual Government Communications Network radio fees.
- Paid NPR Graphics \$6,062 for signage at Stations #72 & #73.
- Paid Jan-Pro Cleaning Systems \$9,060 for disinfection of all 5 stations and 9 apparatus (4x) as preventative measures due to COVID-19.
- Paid 3rd quarterly debt service payment for apparatus capital lease (2 engines) \$25,011.
- Purchased 30 thermal imaging cameras through Municipal Emergency Services \$19,026.

Total expenditures reflect 63.4% of budget and are tracking as expected.

IONA-MCGREGOR FIRE DISTRICT Executive Report

Executive Summary/June 2020:

GENERAL:

- Due to the pandemic, the Center for Public Safety Excellence (CPSE) has restricted travel and site visits for their Technical Advising Program (TAP) through mid-August. In an effort to maintain momentum, we are working with TAP to conduct what was going to be their first site visit through webinar training segments with Administrative staff. This training will occur in June and July and the scheduled second site visit in late August will be the first in-person visit. This adjustment will allow us to continue efforts towards the goal of developing a completed Community-Risk Assessment; a Standards of Cover and community driven Strategic plan.
- We continue to work with partnering agencies in coordinating response efforts to keep personnel and citizens safe during the global pandemic.

OPERATIONS:

- The threats of brush fire season have decreased significantly with the recent emergence of afternoon rain patterns.
- Hurricane season has begun and appears to active already. General pre-season preparations have occurred.
- We have 5 internal candidates training to gain credentials as Acting Lieutenants (fill-in for Lieutenants when needed).
 - This provides a valuable opportunity to further improve this facet of employee development.
- We hope to resume our Ride Time Program by Summer's end, as it has garnered significant positive feedback since beginning with fire academy students last Spring (2019).
- We have distributed new individual use Thermal Imaging Cameras (TICs) to all stations which supports safety in incident response (e.g. Structure fires).
 - Previously, we only had larger TICs on the fire suppression apparatus.

LOGISTICS:

- PSTrax platform for apparatus and gear tracking has launched.
- Hose and ladder testing this month in compliance with standards
- Interior of station 73 painting complete
- New signage for stations in the works (replacing old logo with new)
- Bathrooms at 72 and 73 still in permitting
- Training tower stairs in fabrication
