Meeting Called to Order at 5:05 pm

Roll Call of Commissioners: Commissioners Louwers, Langford, Barbosa and Walker were present. Commissioner Andersen was absent excused.

# Agenda Items

### 1. Presentation of Budget

# a. Discussion of agenda item

Chief Comer said that as we developed the budget, we wanted to keep in mind exceeding expectations through our strategic planning process, during which we heard from the community, and feel the expectations supported with this budget and we will highlight some things as we go through this. Some key objectives are continuous improvement, service delivery excellence, training and development, physical resources, all necessary important components of the mission and vision and the budget supports that. Going forward the budget will be linked to the strategic plan. Adopting this millage rate allows us to do all these things. Chief Comer gave a quick recap of what was discussed during the

budget workshop, such as year over year revenues. Chief Comer then presented a couple of changes, an overall \$20,000 change to what was shown at the workshop, \$18,524 in administration year over year \$150,269 to \$168,983. Since our workshop we've added \$761 that was not reflected, this is for our document management system PowerDMS annual renewal. Operations no change. Prevention we added \$1000.38 for the KnoxBox cloud software subscription. Logistics we added a few things, total of \$16,725, to encompass a few different things such as Class A uniforms, jet dock repair for the marine rescue boat and a \$600 increase for lift station maintenance at station 73. Beyond that everything else is the same.

Commissioner Walker asked what the fund balance was earmarked for to which Chief Finance Officer Winzenread replied that it was earmarked for an estimate of 90 days for operating expenditures from Oct 1 to roughly mid to late December. Commissioner Walker asked what that amount was to which Winzenread replied \$5,859,000. Walker asked what happened to the rest of the money to which Winzenread replied that there is a 45-day reserve for disaster, so if we had a hurricane or some other disaster, we would be prepared. There was some discussion about what was included in capital replacements and what was included in maintenance. Commissioner Louwers did mention that during the budget workshop more details were provided in the breakdown of the specifics of the division budgets.

Attorney Pringle read out resolution number 2022-03 A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE IONA MCGREGOR FIRE PROTECTION AND RESCUE SERVICE DISTRICT ADOPTING A TENTATIVE MILLAGE RATE FOR FISCAL YEAR 2022/2023, COMMENCING ON OCTOBER 1, 2022, AND ENDING ON SEPTEMBER 30, 2023.

NOW THEREFORE, pursuant to Florida Statute \$200.065, the Board of Commissioners of the Iona McGregor Fire Protection and Rescue Service District hereby adopts and sets the tentative operating millage rate of **2.5000** mills (\$**2.5000** per \$1,000.00 of net taxable assessed value) for the fiscal year 2022/2023, which begins October 1, 2022, and ends September 30, 2023. The above stated tentative millage rate of **2.5000** mills **exceeds**/is less than (select one) the rolled back rate of **2.2528** mills by **10.97%**.
