Chief Comer reviewed the budget following on from the budget workshop. He went over the guiding principles that were taken into consideration when putting together the budget. The draft budget was presented, Chief Comer noted no changes to salaries, insurance, administration, operations, prevention, and special ops. budgets. There were changes to the logistics budget \$1,929,969 up from \$1,085,874 due to additions such as building maintenance issues; lighting, key card entry, apron/asphalt issues etc. there were also additions for video conferencing to help facilitate training among crews. Some increases to EMS \$450,049 up from \$414,177 this was due to general increases and Zoll monitor software, and small tools and equipment. Chief Comer said

there were no changes as to how the budget related to the strategic plan. The changes mean the district will use \$4,403,667 of reserve funds during FY2024 with a \$9,430,726 estimated funding balance. The recommendation was for a millage cap of 2.5.

The above stated tentative millage rate of **2.5000** mills **exceeds**/is less than (select one) the rolled back rate of **2.4711** mills by **1.17%**.
