WHEREAS, pursuant to Florida Statute 200.065, the Board of Commissioners of the Iona McGregor Fire Protection and Rescue Service District properly advertised and held a final public budget hearing on Wednesday, September 20, 2023, to adopt a final millage rate for the District's fiscal year commencing October 1, 2023, and ending September 30, 2024. NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE IONA MCGREGOR FIRE PROTECTION AND RESCUE SERVICE DISTRICT THAT:...Section 1. The Board of Commissioners does hereby adopt and set its final operating millage rate of **2.5000** mills (\$ **2.5000** per \$1,000.00 of net taxable assessed value) for the fiscal year 2023/2024, which begins October 1, 2023, and ends September 30, 2024. Section 2. THE FINAL LEVY OF **2.5000** MILLS IS **MORE** / ~~LESS~~ THAN (SELECT ONE) THE ROLLED BACK RATE OF **2.4711** MILLS BY **1.17** %.


